the understanding of multiple perspectives of local and global events and issues, through our pastoral provision and community.

SERVICE...

the development of the understandings, skills and dispositions to serve the local and global community through engagement in meaningful service learning, through work experience, trips and visits and community events in due course – local and international opportunities for students to engage with and experience the joy of service.

SUSTAINABLE LIFESTYLE...

a personal commitment to a lifestyle which supports local and global sustainability displayed through example and advocacy, through our enrichment activities, pastoral and curriculum provision and visitors.

Aims
